I, the undersigned, hereby request and authorize Southern Oklahoma Water Corporation, whose principal office is located in Ardmore, Oklahoma, hereinafter referred to as SOWC, to instruct its engineer to carry out a preliminary engineering review, or water study, to determine the availability of water supply at the location described below.

Therefore, in order for said review to be carried out in a proper fashion, I will furnish SOWC with any available project plans or drawings, information on domestic loading, required fire flows, and any other project information which may be requested by its engineer, as such information may be necessary in order for said engineer to complete the water study. I understand that I must furnish accurate, complete and timely information of the water study to be properly prepared.

I further acknowledge and understand that in order for SOWC to deliver a sufficient amount of water to the project or development described herein below, there may be other required improvements to the property at issue, or other infrastructure installations which may be determined by SOWC and its engineer, and that any such required improvements and infrastructure installations will be determined by SOWC and its engineer, that an additional Engineering Study may be required to determine same, and that any such requirements will be outlined and set forth in a separate Development Agreement between the undersigned, as developer of the property, and SOWC, and that there may be additional fees which I will be required to pay for the completion of any other Engineering Study.

I understand that the SOWC engineer will review existing waterlines and flows, add the undersigned applicant's proposed project and its estimated water demand into a hydraulic model and ascertain whether existing waterlines will serve the project and/or the scope of waterline improvements needed to serve the project. I further understand that SOWC staff will contact me if additional information is needed, that its engineer will forward their findings in a report to SOWC, that SOWC will forward the water study report to the undersigned and that it will take a minimum of 30 days for the water study to be completed.

I acknowledge and agree that should the undersigned fall within SOWC's definition

of a Developer, that the undersigned will be required to enter into a separate Developer's Agreement between the undersigned and SOWC. SOWC defines a developer as "a person or entity which buys or sells real property not for their or its own use, but rather for the purpose of production of business profit, whether through "flipping" the property, or through the subdivision of property or the construction of structures or homes. For an individual, the buying/selling/subdividing of three or more lots annually, necessitates being deemed a developer."

I further understand that the above mentioned water study fee which I have paid concurrently herewith is in payment for the above mentioned water study and that I will not under any circumstances receive any refund or credit for said water study fee which I have paid.

I further understand that this water study does not include any internal or external water study design work for the project nor the engineering fees incurred by SOWC in connection with same and that any of the aforesaid which may be required will be set forth in detail in a subsequent, separate contract between the undersigned and SOWC.
